

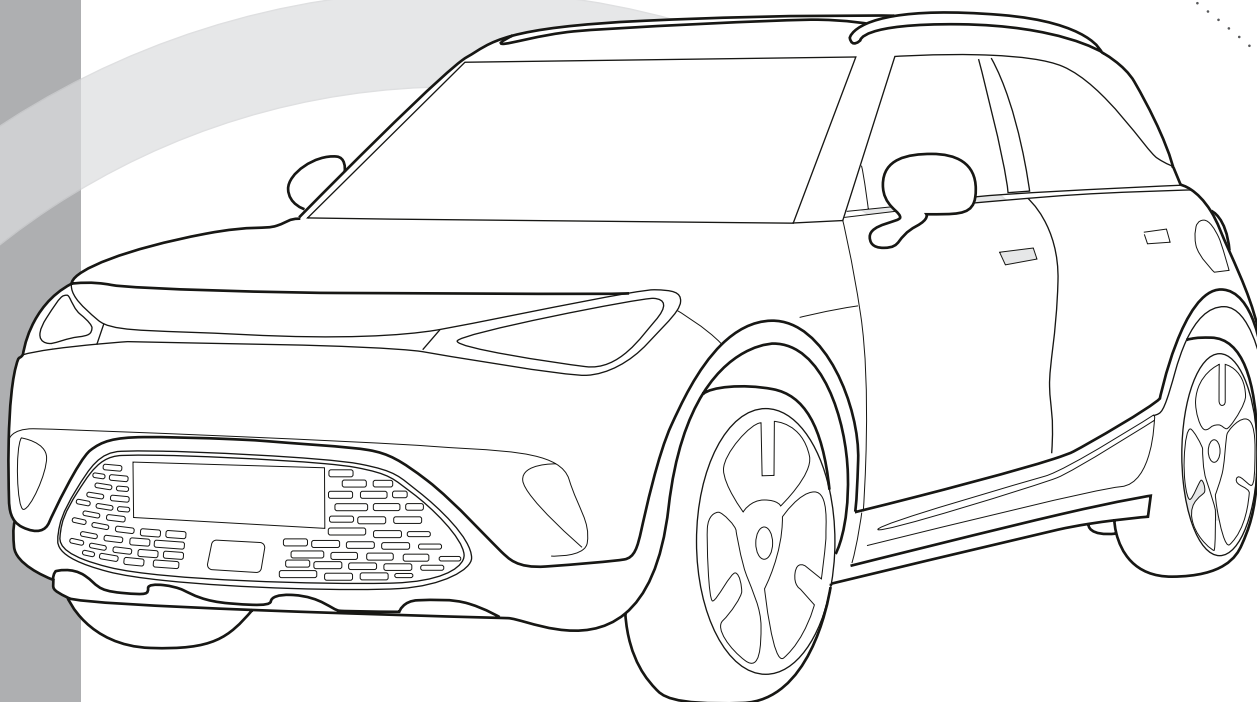

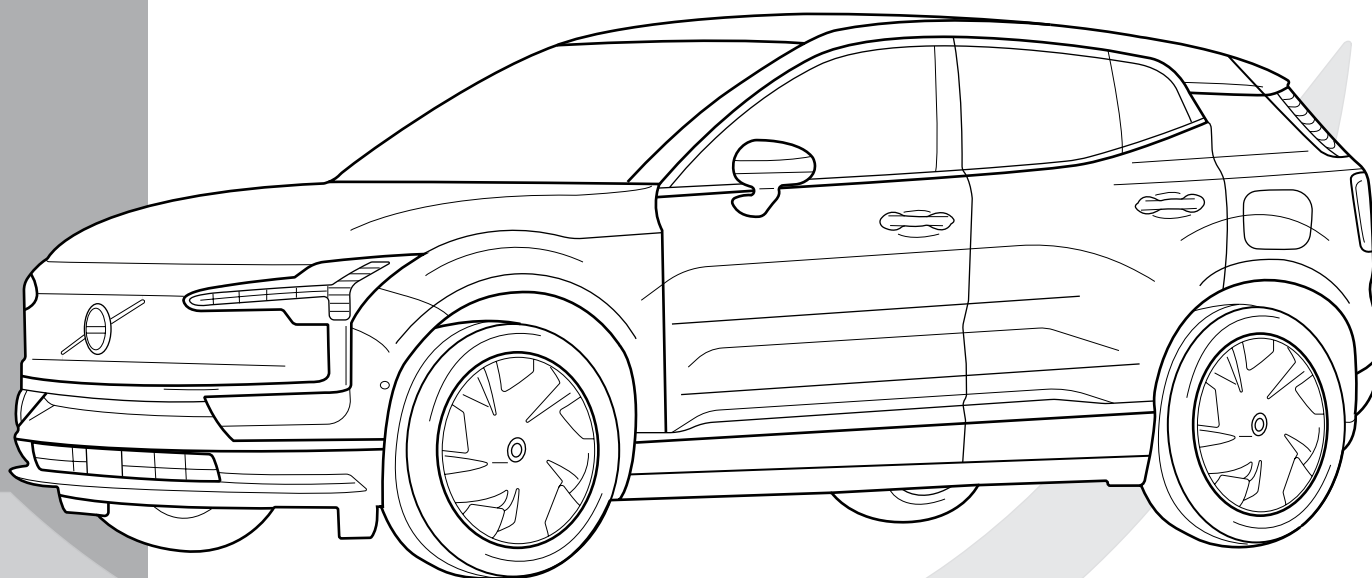

## NL Belangrijke raadgevingen

### Montage

## EN General instructions

### Fitting

- Present the towbar under the car first to check if all points are right.

### Montage

- Halten Sie die Anhängerkupplung zunächst unter das Fahrzeug und prüfen Sie, ob alle Punkte übereinstimmen.
